Dear Cedar House Parents

2023 Cedar House Fees

Thank you to our Principal and our Bursar who have put in so much work to ensure that our 2022 budget is a wise reflection of income and expenditure in the year ahead. We have tried to design 2022 in ways that offer as much value as possible to your children and that also note the economically trying times we are experiencing. Our School is fiscally strong and once again, our audit was also unqualified.

A 8% fee increase has been decided upon for Grades 4-12 students. This means that annual School fees for 2022 will be R118 585 for Grades 8-12 students and R86 490 for Grades 4-7 students, payable over the first 3 Terms. In addition to this, the following levies are payable:

Our 2022 Camp Programme will be guided by the National Covid Regulations. The Grade Days are compulsory for all students.

It would be of enormous benefit to the School if we received 2023 fees upfront. A fee reduction of 3.5% on the base fee applies to those families who are in a position to help us in this way (applicable if paid before 15 February 2023).

I also need to remind you that a full Term's Notice is required in writing should your child not be returning to Cedar House in 2023. We will have to ask for a full term's fees (Term 1 2023) in lieu of notice, should this not be the case. This is a provision included in the contract you signed when you enrolled your child at the school.

Fees must be paid by the first day of each Term. A Trust decision has been taken that students whose 2021 fees are not settled, cannot return to our School in 2023. We are a fee-dependant school and have no alternative other than to institute this decision.

Thank you for your ongoing and much appreciated support of our School.
